Intellectual Property

No source code will be provided to the student. Cluster and Object data will be made available via defined Radar interfaces. As with CES's other customers, any higher-level system created, or integrated, and any knowledge or configuration "secrets" related to features/functions/performance of The Radar remains the IP of CES's customers. CES maintains full IP ownership of The Radar and PLC including but not limited to the: hardware, software, emebedded systems, firmware, mechanical components, and application software to program and configure the radar. CES hereby grants the Student a non exclusive, royalty free license to use the information provided by CES, which has been marked "public" or "redistributable" for its non commercial, teaching and research purposes only.

Warranty No Warranty

System Responsibility:

The Student has the complete system responsibility and CES may only be responsible for the delivery of hardware, software and services, depending on which level of award is determined for a particular applicant.

Sponsorship Cancellation:

Either party can terminate the Sponsorship Program by serving a 30 days written notice upon the other party.

Export Control:
